Manulife Investment Management and Trust Corporation Unit Investment Trust Fund Regular Savings Plan Terms and Conditions

- The Manulife Investment Management and Trust Corporation (Manulife Investment Management) Regular Savings Plan (RSP) is a savings and investment facility that allows an existing Participant ("the Participant") to a Manulife Investment Management Unit Investment Trust Fund (UITF) ("the Fund") to make regular contributions to the Fund.
- The Participant's Manulife Investment Management RSP contributions shall be treated as additional subscriptions to the Fund. The minimum regular contribution via the Manulife Investment Management RSP shall be:
 - Php1,000 for Php-denominated share classes of the Fund USD50 for USD-denominated share classes of the Fund (as applicable) Additional subscriptions to the Fund outside of the Manulife Investment Management RSP shall be based on the minimum additional contribution indicated in the Fund's Plan Rules.
- 3. The Participant's Manulife Investment Management RSP contributions shall be collected from his/her nominated bank account through an auto-debit arrangement (ADA). The list of banks available for the Manulife Investment Management RSP contributions is available upon request of the Participant. The scheduled contributions shall be valued at the end of the business day immediately following the receipt of cleared funds, as confirmed by the Participant's bank.
- 4. To avail of the Manulife Investment Management RSP, the Participant shall submit to Manulife Investment Management a duly filled out and signed Manulife Investment Management RSP Form and ADA Form of the Participant's Bank. The completion of the enrollment to the Manulife Investment Management RSP will be subject to the relevant bank's approval of the Participant's ADA Form. A notice will be sent to the Participant of his enrollment to the Manulife Investment Management RSP.
- Manulife Investment Management shall provide the Participant a confirmation of participation via electronic mail for every successfully processed Manulife Investment Management RSP contribution.
- 6. Should a scheduled contribution date falls on a non-banking day, the deduction shall be made on the next banking day. The same rule shall apply in case of an unscheduled holiday or suspension of trading or banking activities on the date of the scheduled contribution.
- 7. In the event that the Participant's nominated bank account, has insufficient balance to cover the Manulife Investment Management RSP contribution on the scheduled contribution date, no deduction shall be made from the nominated bank account. Hence, there will be no additional subscription to the Fund via the Manulife Investment Management RSP on that scheduled contribution date and the appropriate notice will be sent to the Participant.
- 8. In case the Participant wishes to change the details of his/her Manulife Investment Management RSP enrollment, he/she shall be required to submit to

- Manulife Investment Management a duly filled out and signed Manulife Investment Management RSP Form, indicating therein the requested changes. Where the change involves the Participant's nominated bank account details, he/she shall also be required to submit to Manulife Investment Management a duly filled out and signed ADA Form, in which case, the processing of the change of his/her Manulife Investment Management RSP details will be subject to the relevant bank's approval of the Participant's ADA Form.
- Redemptions of Manulife Investment Management RSP contributions shall be subject to the redemption guidelines indicated in the Fund's Plan Rules. Where the Participant decides to make a full redemption of his participation to the Fund, his/her Manulife Investment Management RSP enrollment shall be deemed cancelled.
- 10. In the event that the Participant's nominated bank account has insufficient balance to cover his/her Manulife Investment Management RSP contribution for three (3) consecutive scheduled contribution dates, his/her Manulife Investment Management RSP enrollment shall be deemed cancelled. A notice that his/her Manulife Investment Management RSP enrollment has been cancelled shall be sent to the Participant.
- 11. Should the Participant decide to cancel his/her Manulife Investment Management RSP enrollment, he/she shall be required to submit to Manulife Investment Management a duly filled out and signed Manulife Investment Management RSP Form indicating therein his/her instruction to cancel his/her Manulife Investment Management RSP enrollment.
- 12. By affixing his/her signature in the Manulife Investment Management RSP Form, the Participant acknowledges that he/she has read, understood and accepted the Manulife Investment Management RSP Terms and Conditions.
